# VALLEY COLLEGE

Valley College Community Enhancement Grant

## **Purpose:**

The Valley College Community Enhancement Grant is designed to encourage individuals that reside in Northern and Southern Ohio to continue their education and build their career path at a career school. The Valley College Community Enhancement Grant is awarded to qualified individuals who reside in the following Ohio counties: Ashland, Cuyahoga, Lorain, Medina, Portage, Stark, Summit, and Wayne. The qualified individual must be enrolled in a Valley College diploma or degree program and **must enroll through the Akron Information Center**. The award is up to \$1,000 per academic year.

### Timing of award and award amount is as follows:

Up to \$1,000 per academic year (applied at the completion of each academic year)

The funds can be applied to tuition, textbooks, uniforms, equipment, lab fees, and other fees that are associated with the specified program.

This Valley College grant will be applied to an account balance owed to the college and has no cash equivalency. It is institutional funding that is applied as a last dollar offset, up to the total amount specified in the award, to the student account balance after all eligible federal, state and local funding has been disbursed to the student's account. The funds can be applied to tuition, textbooks, and other fees that are associated with the specified program.

#### **Terms and Conditions:**

- 1. The Applicant (Student) must provide Valley College with proof of residency\* in the Ohio counties of Ashland, Cuyahoga, Lorain, Medina, Portage, Stark, Summit, and Wayne
- 2. \*Acceptable documentation includes a valid picture ID, utility bill, lease, or written statement.
- 3. The Applicant (Student) must complete the grant application including the essay question.
- 4. The student must enroll in a Valley College online diploma or degree program through the Akron Information Center.
- 5. Failure to graduate from the program for any reason will lead to forfeiture of the grant award.
- 6. The Valley College Community Enhancement Grant is not renewable and may not be combined with other institutional grants.

#### **Application Procedure:**

- 1. Meet with the Financial Aid office to discuss financing options including completing a Free Application for Federal Student Aid (FAFSA) and any additional required documents.
- 2. The prospective students may obtain a grant application from the Valley College Financial Aid office during the admissions process.
- 3. Complete the Grant Application which includes an essay question. All information requested on the application must be complete and legible. The application must be signed by the applicant.

#### **Submission Process:**

The completed Grant Application must be submitted to the Financial Aid Department. Incomplete application packets will not be accepted. The Financial Aid Advisor will forward all completed applications to the Campus Director. The Director of Financial Aid will grant the final approval.

# Allied Health MAA Diploma

Step-Up Scholarship Application Scholarship Deadline – September 28, 2020 You must start your new program on or before September 28, 2020.

# **Purpose:**

The Allied Health MAA Diploma Step-Up Scholarship is intended for qualified graduates, from the Valley College Medical Administrative Assistant (MAA) diploma program, who enrolls in a Valley College Applied Associate of Business degree or a Bachelor of Science programs offered online. This scholarship is designed to encourage the graduate to further their education and develop additional technical, communication, and managerial skills that can lead to more employment opportunities. The applicant is considered a candidate for the scholarship during his or her enrollment in the Associate or Bachelor degree program.

### Timing of award and award amount is as follows:

• This scholarship is a no debt scholarship meaning that the award will consist of the cost of the program, books, and fees minus any grants (federal or state) received by the student. The scholarship has no cash equivalency and will not be applied to any previous balance that the student may have with Valley College.

## **Terms and Conditions:**

- 1. Enrollment in the Valley College AAB or Bachelor degree program offered online. The student should start their program on or before September 28, 2020.
- 2. Must have started the MAA Diploma program between the periods of March 1, 2018 to February 28, 2019 and graduated from the program but has not found gainful employment in their field **OR may not have** not previously enrolled (attended classes) in an associate or bachelor degree program at Valley College.
- 3. Complete the scholarship application including an essay question by the September 28, 2020 deadline.
- 4. This scholarship cannot be combined with any other Valley College scholarships.
- 5. Failure to complete/graduate from the degree program for any reason will lead to forfeiture of the scholarship award. Application Procedure:
  - 1. Meet with the Financial Aid office to discuss financing options including completing a Free Application for Federal Student Aid (FAFSA) and any additional required documents.
  - 2. The prospective students may obtain a grant application from the Valley College Financial Aid office during the admissions process.
  - 3. Complete the Grant Application which includes an essay question. All information requested on the application must be complete and legible. The application must be signed by the applicant.

### **Submission Process:**

The completed Grant Application must be submitted to the Financial Aid Department. Incomplete application packets will not be accepted. The Financial Aid Advisor will forward all completed applications to the Campus Director. The Director of Financial Aid will grant the final approval.

# Allied Health MAA Diploma

Step-Up Scholarship Application Scholarship Deadline – September 28, 2020 You must start your new program on or before September 8, 2020.

# **Purpose:**

The MAA Completion Scholarship is intended for students who started the MAA program between March 2018 and February 2019, but for whatever reason left the program prior to completion either voluntarily or involuntarily. Valley College is offering this scholarship to those students who wish to return to complete any Valley College diploma or degree program. The recipients for this (scholarship) cannot have graduated from the MAA program or transferred to another program before the date 6/17/2020. Scholarship recipients will be determined by the Valley College Scholarship Committee and approved by the Director of Financial Aid.

#### Timing of award and award amount is as follows:

• The award is up to \$5,000 (Five Thousand dollars) and will be applied upon successful completion of the program.

This scholarship is a no debt scholarship meaning that the award will consist of the cost of the program, books, and fees minus any grants (federal or state) received by the student. The scholarship has no cash equivalency and will not be applied to any previous balance that the student may have with Valley College.

#### **Terms and Conditions:**

- 1. Must meet the College's returning status programmatic admissions requirements
- 2. Must meet the College's Admissions requirements for the program you are enrolling in.
- 3. Completion of the scholarship application including the essay question.
- 4. If the scholarship applicant's previous cGPA is below a 2.0, the applicant must work with the Director of Academic Affairs to develop an Academic Action Plan by the end of the first week of class.
- 5. Failure to graduate from the program for any reason will lead to forfeiture of the scholarship award.
