Furthering Education Grant Application

Grant Deadline – September 6, 2022.

The Veterinary Assistant Diploma Program Furthering Education Grant is intended for qualified graduates, from the Valley College Veterinary Assistant program who want to change their career path and wants to enroll in a program offered and administered by Valley College - Cleveland. The applicant is considered a candidate for the grant during his or her enrollment in the degree program. The funds may be used for tuition, required fees, and books.

Timing of award and award amount is as follows:

Credential	Amount of Award	Timing of the Award
Associate Degree or Diploma	Up to \$7,000	Up to \$7,000.00 will be awarded upon successful completion of the program.

This Valley College Grant will be applied to a current account balance owed to Valley College and has no cash equivalency. It is institutional funding that is applied as a last dollar offset, up to the total amount specified in the award, to the student account balance after all eligible federal, state, and local funding has been disbursed to the student’s account. The grant will not be applied to any balance that the student may have with Valley College from the Veterinary Assistant program.

Terms and Conditions:

1. Enrollment in a Valley College program offered at Valley College - Cleveland. The student must start their program on or before September 6, 2022. The student must meet all admissions requirements for the program that they are enrolling in.
2. The student must have started the Veterinary Assistant program between January 2020 and December 2020) and graduated from the program but has not found gainful employment in their field and are not already continuing their education in another Valley College program.
3. Complete the grant application including an essay question by the September 6, 2022, deadline.
4. This grant cannot be combined with any other Valley College grant.
5. Failure to complete/graduate from the program for any reason will lead to forfeiture of the grant award.

Application Procedure:

1. Meet with the Financial Aid office to discuss financing options.
2. The prospective students may obtain the appropriate application from the Valley College Financial Aid office during the admissions process.
3. Complete the application which includes an essay question. All information requested on the application must be complete and legible. The application must be signed by the applicant.

Submission Procedure:

The completed application must be submitted to the Financial Aid Department. Incomplete application packets will not be accepted. The Financial Aid Advisor will forward all completed applications to the Campus Director. The final approval is granted by the Director of Financial Aid.

It is institutional funding that is applied as a last dollar offset, up to the total amount specified in the award, to the student account balance after all eligible federal, state, and local funding has been disbursed to the student's account. The scholarship will not be applied to any balance that the student may have with Valley College from the Veterinary Assistant program.

1. Enrollment in a Valley College online program offered 100% online through Valley College - Martinsburg. The student must start their program on or before September 6, 2022.
2. The student must have started the Veterinary Assistant (program between January 2020 and December 2020) and graduated from the program but has not found gainful employment in their field and are not already continuing their education in another Valley College program.
3. Complete the scholarship application including an essay question by the September 6, 2022, deadline.
4. This scholarship cannot be combined with any other Valley College scholarships.
5. Failure to complete/graduate from the degree program for any reason will lead to forfeiture of the scholarship award.

Application Procedure:

Reconnect Scholarship Application
Valley College - Martinsburg

Deadline prior to the start of classes on September 6, 2022
You must start classes on or before September 6, 2022

The Cybersecurity Associate Degree program Reconnect Scholarship is intended for students who started the Cybersecurity Associate (AAS) program between April 1, 2019, through March 31, 2020, but for whatever reason left the program prior to completion either voluntarily or involuntarily. The applicant is considered a candidate for the scholarship during his or her enrollment in the diploma/degree program. The award may be applied toward tuition, lab fees, and /or books. Scholarship recipients will be determined by the Valley College Scholarship Committee and approved by the Director of Financial Aid.

Timing of award and award amount is as follows:

Credential	Amount of Award	Timing of the Award
Diploma	Up to \$5,000	The Diploma program’s award will be applied upon successful completion of the program.
Associate Degree	Up to \$5,000	\$2,500 will be awarded at the successful completion of each academic year. There are two academic years in an Associate’s degree program.
Bachelor Degree	Up to \$5,000	\$1,250 will be awarded at the successful completion of each academic year. There are four academic years in a Bachelor's degree program.

Terms and Conditions:

1. Must meet the College’s returning status programmatic admissions requirements
2. Must enroll in the any Valley College program offered through the Martinsburg campus and **start classes** on or prior to 9/6/2022.
3. Completion of the scholarship application including the essay question
4. If the scholarship applicant’s previous GPA is below a 2.0, the applicant must work with the Director of Academic Affairs to develop an Academic Action Plan by the end of the first week of class.
5. Failure to graduate from the program for any reason will lead to forfeiture of the scholarship award.

Application Procedure:

1. Meet with the Financial Aid office to discuss financing options.
2. The prospective students may obtain the appropriate application from the Valley College Financial Aid office during the admissions process.
3. Complete the application which includes an essay question. All information requested on the application must be complete and legible. The application must be signed by the applicant.
